

**oGoLead™ Heartwiring Leaders, Hardwiring Success™
Online Course License Agreement**

This oGoLead™ Heartwiring Leaders, Hardwiring Success™ Online Course License Agreement ("License Agreement") is between you ("you" or "your") and oGoLead, LLC and its affiliates ("oGoLead" or "We"), and governs your use of the oGoLead Heartwiring Leaders, Hardwiring Success™ online course, including any user instructions and any other materials provided by, whether in print, electronic, or other format (the "Course Software").
